## **Assistance Available/Provided by One Voice for Volusia:**

- Facilitate Determined Number of Meetings
- Coordinate Workshops/Trainings (*number and details to be determined and finalized pending approval by Committee*)
- Research and Collect Available Data Pertinent to Your Targeted Population
- Facilitate Trainings, Focus Groups, Listening Sessions, Small and Large Group Discussion
- Evaluate Initiative/Project Outcomes and Effectiveness

## **Proposed Criteria for Eligible Applicants:**

Eligibility guidelines include:

- Must involve multi-agency involvement and focus, from a variety of organizations.
- Must share a common goal, issue or purpose.
- Must have an established working relationship with noteworthy successes to share.

Eligible applicants would complete a **Request for Consideration** (attached) and indicate:

- Whether the group wants to **build capacity by creating or modifying existing services or other activities**
- **Maximize resources** (combine or organize more efficiently)
- Create **new or modify existing public and/or organizational policies**
- **Develop changes within the system**, create or enhance agency/group relationships
- **Develop community and social participation** – facilitate participation and leadership, strengthen networks norms, social trust, effect improvement in social-economic environmental conditions

It is expected that collaboration will result in commitment of resources and will recognize community projects or initiatives that demonstrate collaboration.

Each **Request for Consideration** would be approved by the Systems and Data Committee on a case-by-case basis, based on committee and available resources. One Voice for Volusia staff would forward the request to committee for ultimate approval and respond to the collaborating group/coalition accordingly in a timely manner.
