WELCOME/APPROVAL OF MINUTES/COALITION BUSINESS

The meeting was called to order at 9:00 a.m. by Julie Barrow. Cher Philio then welcomed everyone and thanked them for coming, saying that a copy of the minutes would be available upon request at nichole@ovfv.org. She then let everyone know that there was no meeting sponsor this month, and encouraged anyone who would like to have more than 30-sec to make an announcement or talk about their agency to consider sponsoring a future meeting. Sponsorship helps to cover the cost of meeting materials as well as the snacks and refreshments that are provided. Roundtable introductions ensued

COALITION BUSINESS

Julie called the meeting back to order. She then introduced Jamie Barkley, Membership Director for the Daytona Regional Chamber who led the group in an extended networking exercise. Jamie asked each person to introduce themselves to someone new and take time to find out how they can help one another. He also encouraged everyone to set up a time to meet, whether that be at their place of work or out to lunch, to follow up. He then made an announcement on behalf of One Voice for Volusia, that One Voice now has a Facebook page. He asked everyone to pull out their phone and "like" their page right there on the spot to show their support for the organization. He concluded the exercise by saying that networking is as simple as introducing yourself and encouraged everyone to make the most of the time at meetings such as the One Voice for Volusia monthly coalition meeting.

Julie thanked Jamie for taking the time to lead us in the exercise. She then thanked those who have sent in the membership subscription for the 2016-17 fiscal year which started in July, and asked those who had not re-subscribed yet to please send in their payment as it helps One Voice to continue all they do in the community.

Next, she spoke about the Health and Human Services Summit that is coming up on October 28th and the Ocean Center in Daytona Beach. She thanked all the sponsors and current vendors for supporting the event and said she hoped it would be the best one yet. She also encouraged everyone to go on the One Voice for Volusia website and pre-register for the training classes that will be held during the event. She reminded everyone that there would be limited seating so pre-registering is highly recommended beforehand.

Julie then took a moment to speak about the Community Agenda. She said that the information was updated on September 30th, and that it can be viewed on the One Voice for Volusia website, and print copies are available by request for a fee. She also said that the youth substance abuse prevention initiative Friday Night Done Right has been expanding in our community. She thanked the Volusia/Flagler YMCA for allowing us to participate in their events. She then asked those attending the meeting to take the Parents Who Host Lose the Most Pledge that they would not host underage drinking in their homes, as 82% of Volusia teens who drink are doing so in their own home or the home of a friend (2014 FYSAS data). Pledge cards are available at the meetings and by request. She also issued a challenge to the group, to take a stack of Parent's Who Host cards and get them signed by friends, family, colleagues, and anyone else they could think of. She asked that they get the cards signed and bring them back to the December meeting, and that the organization who had the most cards would be rewarded with either a year's subscription to One Voice or a Meeting Sponsorship. She also said that the moving PSA on Suicide that was presented by Caitlin at a previous meeting would be available soon on the One Voice website.

MONTHLY TOPIC

Cher then introduced Micky Beauregard, Education and QA Specialist for the Domestic Abuse Council. Micky began by saying that October is Domestic Violence Awareness Month. She said that in 2015 there were over 4,500 cases of domestic violence reported in Volusia County, and 6049 calls to the Domestic Abuse Hotline. She said that stalking has been a huge issue, with our current technology making it that much easier for someone to do. She said that we should all be aware of those around us and their current situations. Things like way too many phone calls at work could be a sign of harassment or stalking. She also said that emotional and verbal abuse are extremely common, where one person beats the other one down with their words, making them feel worthless. She encouraged everyone to stay safe with their social media use. She said not to give out too much information, such as your location. It may seem like fun to post your every move on Instagram but it makes you easy to find as well, which can be dangerous. She also encouraged everyone to lie. When you set up your passwords and the automatic generator comes up asking for answers to things like "Where were you born" or "Your first pet's name" that there is no reason you can't make something up. These answers can be easy for someone that knows you to figure out, and if you no long wish to have contact with an individual they can still find out all about you if they can get into your accounts. She said to come up with answers that are easy for you to remember but are not true so that only you can access your accounts. She thanked everyone for their ongoing support and asked that they wear purple or pink in support of Domestic Violence Awareness. Julie took a moment to say that Know the Law, which One Voice for Volusia teaches in our local schools, helps to keep the kids safe by teaching them some of the dangers and ramifications of using social media. She gave the example of a young lady who lost a scholarship due to content on her Facebook page, and said you never know who is checking up on you. It can be a family member, college admissions officer, or even a potential employer.

Cher then introduced Crystal Elkins of Panda Designs & Marketing. Crystal started by saying that social media can be a great tool for non-profit organizations as it can raise awareness in your community and beyond. She said that there are currently 1.7 billion people on Facebook, and on average people check their social media at least three times each day. If your focus is teenagers, they are mostly using Instagram and Snapchat so those can be helpful platforms to get your message out. She also said that you can't expect to get 1 million or even 1,000 followers right away, or that you will raise a lot of money. It takes time to build your social media sites and get the word out about your organization. She said that she helps to build a complete brand experience, like she is currently doing for One Voice for Volusia. One Voice has currently launched not just a Facebook page, but also Instagram and Twitter accounts. She concluded by taking a moment to go Live on the One Voice for Volusia Facebook account and had everyone wave.
